

**FONT LICENSE AGREEMENT**

The license is for fonts. The fonts contain digitally-encoded machine-readable outline font programs (Outline Fonts) and metric information. The screen font data and the Outline Fonts are hereafter called the "Software."

Licensor will at its option replace the Software not meeting the warranty or refund the license fee for the Software.
